<p><b>Visitation:</b> permitted between 9:00 am – 9:00 pm. No appointment required</p> <p><b>Each resident (or substitute decision maker) will identify two essential visitors to the home.</b> If individual is not currently on the list, advise that they must contact Roxanne Adams at roxannea@copernicolodge.com during regular business hours to make these arrangements</p> <p><b>Proof of a negative COVID-19 test that was taken in the last two weeks MUST be shown</b></p> <p>Only one caregiver is allowed to visit their loved one at a time. Must complete and pass the <b>LTC FAMILY / CAREGIVER VISITATION - COVID-19 ACTIVE SCREENING TOOL</b> each time they enter and leave the home and must wear full PPE</p> <p>Caregivers will be required to watch an educational video on proper use of PPE's and infection control protocols</p> <p>The visitation will take place in the resident's room.</p> <p>NO restrictions on how long an essential caregiver can stay with resident</p>	<p><b>Visitation:</b> permitted 24 hours per day.</p> <p>All visitors <b>must</b> be on the designated visitor list for LTC</p> <p>Only one care giver is allowed to visit their loved one at a time.</p> <p>A Negative COVID swab is <b>NOT</b> required</p> <p>Must complete and pass the COVID-19 screening each time they enter and leave the home and must wear full PPE</p>	<p>Short term and temporary absences are not permitted.</p> <p>Short term absence is defined as leaving the home's property for social or other reasons that does not include an overnight stay.</p> <p>Temporary absence is defined as leaving the property for social or other reasons that include one or more nights.</p>	<p>Residents are permitted to take a medical absence from Copernicus Lodge.</p> <p>A medical absence is defined as leaving the home's property for medical reasons (i.e. outpatient visits, single night emergency room visit.</p> <p>An emergency room visit that takes place overnight and discharge from emergency department spans one overnight period are considered equivalent to an outpatient medical period.</p>	<p><b><u>No COVID test required</u></b></p> <p>Location – ground floor parking entrance (in front of ground floor LTC elevators)</p> <p>Visits must be pre-booked and are booked for 30 minutes' sessions (1x/week).</p> <p>Visits are between 11:30am - 6:15 pm</p> <p>No limit to number visitors as resident separated by glass windows/door</p> <p>Please visit our website to book your window visit.</p>	<p><b><u>No COVID test required</u></b></p> <p>Location – with use of iPad or cell phone the visits take place on the RHAs in the Activity Rooms, RHA lounges or resident's room.</p> <p>Visits must be pre-booked and are booked for 30 minutes' sessions (1x/week), however, for residents who are able to communicate and meet virtually independently with only set up support they are allotted more time.</p> <p>Please visit our website to book your virtual visit.</p>
