<p>Visitation: permitted 24 hours per day. No appointment required</p> <p>Each resident (or substitute decision maker) will identify the two essential visitors to the home. If individual is not currently on the list, advise that they must contact #230 during regular business hours to make these arrangements</p> <p>Proof of a negative COVID-19 test that was taken in the last two weeks must be shown</p> <p>Must complete and pass the LTC FAMILY / CAREGIVER VISITATION - COVID-19 ACTIVE SCREENING TOOL each time they enter and leave the home and must wear full PPE</p> <p>Caregivers will be required to watch an educational video on proper use of PPE's and infection control protocols</p> <p>The visitation will take place in the resident's room.</p> <p>NO restrictions on how long an essential caregiver can stay with resident</p> <p>If they want to take resident outside, they must notify the nurse on the unit and complete the "Short Absence" form at reception</p>	<p>Visitation: permitted 24 hours per day.</p> <p>All visitors must be on the designated visitor list for LTC</p> <p>A Negative COVID swab is NOT required</p> <p>Must complete and pass the COVID-19 screening each time they enter and leave the home and must wear full PPE</p>	<p>Families are required to contact the Nursing station to coordinate pick up and drop off time for the resident</p> <p>Visitor must be the POA to take the resident out of the home. (If visitor is not the POA, prior approval will be obtained)</p> <p>Resident will be escorted to reception by staff.</p> <p>Family must complete the: Visitation COVID-19 Screening/Contact Tracing Tool prior to leaving with resident and upon return. Families will not be permitted into the LTC home unless they are a designated Essential Visitor.</p> <p>Both resident and family must wear a medical mask at all times when outside of the home and reminded about the importance of public health measures including physical distancing.</p> <p>Upon return to the home, residents must be actively screened</p>	<p>The Resident or POA must contact the Administrator or designate to review and approve all requests for overnight LOA's.</p> <p>These will be approved on a case by case basis</p>	<p>NO COVID test required Location of Visit: ground floor courtyard with entrance from Marion Street.</p> <p>Visitation: between 11:30am - 6:15 pm</p> <p>For each time slot visits will be restricted to residents of same Resident's area</p> <p>Visits must be pre-booked and are booked for 30-minute sessions (1x/week).</p> <p>For booking an outdoor visit please contact 416-536-7122 x237</p> <p>2 visitors at a time permitted for each resident.</p> <p>Visitors will be required to go through a screening process</p> <p>Visitors must wear surgical mask</p> <p>Hand Hygiene required – hand sanitizing</p> <p>Physical distancing required during visit</p>	<p>COVID Negative Test required within the last 2 weeks</p> <p>Location of visit: Multipurpose Room</p> <p>For each time slot visits will be restricted to residents of same Resident's area</p> <p>Visitation: between 11:30am - 6:15 pm</p> <p>Visits must be pre-booked and are booked for 30 minutes' sessions (1x/week).</p> <p>For booking an indoor visit please contact 416-536-7122 x237</p> <p>2 visitors at a time are permitted for each resident.</p> <p>Must complete and pass the COVID-19 screening each time they enter must wear MASKS throughout the visit</p> <p>Hand Hygiene required – hand sanitizing</p> <p>Physical distancing required during visit</p>	<p>No COVID test required</p> <p>Location – ground floor parking entrance (in front of ground floor LTC elevators)</p> <p>2nd window option is set up in the ground floor courtyard gate but this space is not available when there are outdoor visits booked</p> <p>Visits must be pre-booked and are booked for 30 minutes' sessions (1x/week).</p> <p>Visits are between 11:30am - 6:15 pm</p> <p>No limit to number visitors as resident separated by glass windows/door</p>	<p>No COVID test required</p> <p>Location – with use of iPad or cell phone the visits take place on the RHAs in the Activity Rooms, RHA lounges or resident's room.</p> <p>Visits must be pre-booked and are booked for 30 minutes' sessions (1x/week), however, for residents who are able to communicate and meet virtually independently with only set up support they are allotted more time.</p> <p>Currently we have the following regular virtual / telephone connections each week:</p> <p>Stats Face Time = 26 Skype = 13 Telephone call/ update = 34 Zoom = 1 ----- Total 74</p>
